

Ndal Manufacturing Industries, Inc Policy Regarding Minimum Advertised Pricing (MAP)

Product: ALL PRODUCTS

Policy Effective Date: **SEPTEMBER 1, 2015**

Ndal Manufacturing Industries, Inc., ("Ndal") has determined, through this company policy dated SEPTEMBER 1, 2015, that it shall not support or approve any advertised pricing that may have the effect of diminishing or detracting from the perceived value of the ManukaGuard brand. This MAP policy relates to the current or future sales of ManukaGuard Products to any company either through broker, direct purchase from Ndal and/or through an Ndal authorized distributor/wholesaler ("Distribution Sources"). Your company "The Company" agrees that the following terms and conditions will be complied with:

- 1. "Ndal" has established a Minimum Advertising and Pricing ("MAP") policy for ManukaGuard products. This "MAP" policy may be adjusted by "Ndal" at its sole discretion upon sixty (60) days notice to "The Company" by email, fax or letter either directly from "Ndal" or through any "Ndal" authorized "Distribution Sources". "The Company", for the purposes of this MAP policy, is defined as an entity or operation that purchases ManukaGuard products from any "Ndal" authorized "Distribution Source", and re-sells or intends to re-sell to new or current individual consumers (general public) or retail accounts (retailers).
- 2. This MAP policy only applies to advertisements for all ManukaGuard products in any and all media types, including but not limited to: flyers, posters, coupons, mailers/emails, inserts, newspapers, magazines, catalogs, mail order catalogs, website, Internet or similar electronic media, television, radio and other public displays. This MAP policy is not applicable to any instore advertising that is not distributed to any customer by the media types listed in this paragraph.
- 3. This MAP policy specifically calls for a minimum allowed advertised price for all ManukaGuard products of 25% off Manufacturer Suggested Retail Price ("SRP").
- 4."The Company" understands that a violation of this policy may be grounds for termination of the right to sell ManukaGuard Products.
- 5. "Ndal" may, at its discretion, modify or suspend this MAP policy and notify "The Company" of such, through any applicable "Ndal" authorized "Distribution Sources". It is the responsibility of "Ndal" authorized "Distribution Sources" to timely notify "The Company" of any modifications or suspension of this MAP policy in writing by e-mail, fax or letter.
